All classes will run in catalog order on Friday and Saturday (ascending jump height beginning with the lowest jump height) and in reverse catalog order for Sunday (descending jump height beginning with the highest jump height entered). Exceptions may be made for handlers with multiple entries with permission from the judge.

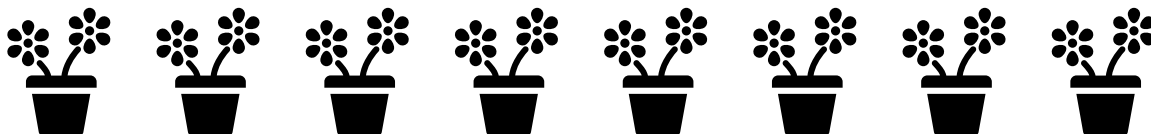

## COVID GUIDELINES & PROTOCOLS

These guidelines are designed with the safety of event participants, volunteers, and judges in mind. These guidelines are provided in advance to allow exhibitors time to make informed decisions about whether to participate in this trial. If you feel that your safety is at risk, or you cannot comply with these guidelines, please do not enter this event.

1. **Waivers:** Upon checking in on the first day entered, Exhibitors will be required to sign a COVID-19 waiver. A copy of the waiver is included in this premium on page 7.
2. **Face Coverings:** Masks are required to be worn in the building. Masks should be well-fitting, cover the nose and mouth. Face shields may be used in conjunction with masks but not instead of masks. Masks will be available for purchase if an exhibitor forgets to bring one.
3. **Restrooms and Hygiene:** Indoor bathrooms will be available for use by exhibitors. Exhibitors are expected to make frequent use of hand sanitizers.
4. **Social Distancing:** Exhibitors will be expected to observe 6' of social distancing.
5. **Building Entry:** Entrance and exit will be through separate labeled doors.
6. **Check-in:** A table will be set-up outside for Exhibitor check-in. Each Exhibitor will be provided with their armbands, a corresponding sign(s) for their vehicle window, rubber bands, and Rally maps (if applicable). Exhibitors need only check in once for all classes each day. Exhibitors do not need to check-in at the ring. **Important:** If you will be absent from any classes, please advise the secretary.
7. **Spectators:** This event is closed to the public.
8. **Time in the Building & Warm-ups:** Exhibitors will stage outside the designated entry door. A warmup ring and "on deck" area will be available inside the building. (1) As one team finishes their run and exits the ring, and (2) the Exhibitor in the "on deck" area is called to enter the ring, (3) the exhibitor in the warm-up area may move to the "on deck area"; and (4) the next Exhibitor may enter the building to begin their warmup. Exhibitors will be expected to leave the building after judging.
9. **Walk Throughs for Rally and Beginners Novice:** Walk-throughs will take place in small groups as determined by the judge.
10. **Crating and Chairs:** There will be no indoor crating at this trial. Exhibitors should be prepared to crate from their vehicles.
11. **Placement, New Title, and Awards:** Awards and placements will be given in the ring. Qualifying ribbons will be placed on a self-service table outside the ring. Exhibitors will be responsible for collecting their ribbons.

## DIRECTIONS TO SHOW SITE

### From Greenville/Atlanta on I-85 North

- Take EXIT 66, the US 29 exit, toward Wellford/Spartanburg West, keep left on the ramp.
- At the end of the ramp turn left toward Wellford/Lyman.
- Turn Left onto Greenville Hwy/US-29 S.
- Turn right onto Syphrit Rd.
- Turn left onto Carver St, Carver St. is just past Astor St.
- If you reach Brook St., you have gone about 0.3 miles too far.

### From Charlotte

- Take I 85 toward Greenville/Spartanburg
- Take EXIT 66, US-29 toward Lyman/Wellford at end of ramp turn right.
- Turn right onto Syphrit Rd.
- Turn left onto Carver St, Carver St. is just past Astor St.
- If you reach Brook St., you have gone about 0.3 miles too far.

### From Columbia, SC

- Take I 26 West Toward Spartanburg
- Merge onto US-29 South viz Exit 21A toward Greer.
- Turn right onto Syphrit Rd.
- Turn Left onto Carver Street. (see above)

### From Asheville, NC

- Take I-26 toward I-40
- Take EXIT 10; the SC-292 exit toward Inman.
- Turn Right onto Highway 292/SC-292 continue to follow SC-292.
- Turn Left onto N. Main St. /SC 292 continue to follow SC-292.
- Turn left onto Bobo Rd. Bobo rd. becomes Carver St.

No RV parking on property. No overnight parking allowed. Dogs may not be left in building overnight.

## OBEDIENCE/RALLY TRIAL RULES

1. Dogs must have an AKC registration number, FSS, PAL, ILP number or be enrolled in the AKC Canine Partners program (mixed breeds).
2. Separate entry forms must be completed for each dog entered.
3. Fees must accompany entries. GKC assumes no responsibility for incomplete or inaccurate information on the entry form or for a dog being entered in a class for which it is not eligible.
4. Entries must be on the current, official American Kennel Club entry form. Conditional, unsigned, or incomplete entries will not be accepted.
5. Entry fees will not be refunded in the event a dog is absent, disqualified, excused by a veterinarian or judge, or barred from competition by action of the Trial Committee.
6. Bitches in season are not permitted to compete in Rally or Obedience Trials, and the entry fee may be refunded for bitches proven to be in season on the date of the trial. Refund requests must be made to Trial Secretary prior to the start of trial judging.
7. The Trial Committee may decline any entry for cause or may remove any dog on account of sickness or other cause and no one shall have any claim or recourse against GKC or any trial official thereof.
8. The Greenville Kennel Club, Inc. is not responsible for the loss or damage to any dog exhibited, whether it results from an accident or other cause. It is to be clearly understood that every dog at this trial is in the care, custody and control of the owner or his/her agent always.
9. Dogs need be present only for scheduled judging and will be released if not needed for further judging.
10. It is the responsibility of the exhibitor to have their dog ready to be shown and at the entrance of the judging ring at the appropriate time. It is not the responsibility of the ring steward or any other officer or agent of the club to locate any dog for judging.
11. Transfers will be accepted at these trials according to the provisions stated in American Kennel Club, Obedience and Rally Regulations
12. In the event of a tie score for any award, it will be the responsibility of the handler to have the dog available for a runoff. Any dog that is not present for the runoff forfeits its right to the award.
13. No double handling will be permitted at this trial. Individuals who attempt to double handle from outside the ring will be subject to action by the Trial Committee.
14. The Trial Committee reserves the right to cancel the trial in the event of extreme weather conditions as per AKC directive dated July 23, 1995.
15. Members and officers of GKC, trial committee members, the trial secretary, and family members of those listed will be allowed to show dogs at these trials.
16. There will be NO SMOKING inside the building or outside within 25 feet of any doorway into the building.
17. All exhibitors are expected to clean up after their dogs at this trial site.
