3. Drop-in Guests will supervise and maintain control of their dog(s) during training sessions and while on the premises. Dogs must be crated when not attended by member. No exceptions.
4. Children under 18 years of age must be accompanied and supervised by an adult.
5. Dog nails should be kept trimmed to avoid damage to mats and injury to the dog.
6. At end of training session, drop-in guests should store equipment in racks or areas designated for storage.

### TRAINING GUIDELINES

1. A "training session" is one-hour unless no one is waiting to use the ring. If no one is waiting, a training session may extend beyond one hour.
