## HAPPY DOGS TRAINING CENTER - MEMBERSHIP AGREEMENT

**ACCEPTANCE OF LIABILITY, RISK, AND INDEMNIFICATION:** I am responsible for the successful training, control and conduct of my dog at all times while on the premises of Happy Dogs Training Center. I am solely liable for any injury to persons or damage to property caused by my dog. I hold harmless, indemnify, and defend Happy Dogs Training Center, LLC from all injuries or damage caused by me or my dog whatsoever.

**DECLARATION OF PET'S HEALTH:** My dog is in good health, not injured and is free of internal/external parasites, communicable diseases, and has received appropriate vaccinations including Bordetella.

### HOUSEKEEPING RULES

1. Members will sign the training log when they arrive and leave the building.
2. At the end of a scheduled training session, members agree to use the Ryobi cordless shop vac (located in the crating area) to vacuum hair, food debris and visible dirt from the training rings and around crates used during training session.
3. Members further agree to store extra boards and training aides in racks or areas designated for storage, clean crates, training table and stanchions used as a food target.
4. Members should wipe up dog slobber, spilled water, food residue and stains with a cloth (moistened with water) or mop (located in storage room). Slobber and spilled water left on the floor becomes a dirt spot when it dries.
5. Training sessions are not scheduled for 75 minutes to training time. This time is built into the schedule to allow time for members to clean after training.
6. Members agree to clean up and dispose of dog waste outside and outside the building. Members agree to use the mop (located in the storage closet) to clean when their dog has an accident in the ring. Paper towels used to clean dog's accidents in the building should be placed in a sealed bag together with the dog waste and deposited outside in the dog waste receptacle.
7. Do not let your dog urinate in front of the building, on the building, flowerpots or on the waste receptacle. If a mistake occurs, please clean up after your dog.
8. Members will supervise and maintain control of their dog(s) during training sessions and while on the premises.
9. Dogs must be crated when not attended by members. No exceptions.
10. Children under 18 years of age must be accompanied and supervised by an adult.
11. Members agree to keep their dog's nails trimmed to avoid damage to mats and injury to their dog.

### TRAINING GUIDELINES

1. There may be days and times when one or more of the rings are not available. These days and times will be posted on the Training & Event calendar.
2. Happy Dogs Training Center reserves the right to establish and maintain a scheduling system. Members are required to schedule training times by sending an email message to [INFO@HappyDogsTC.com](mailto:INFO@HappyDogsTC.com). Members are required to notify us as soon as possible when they cannot make their reserved time so other members can use it.
3. Members are responsible for their guests including compliance with the Housekeeping guidelines set forth in this membership/renewal agreement.

6. A "training session" is one-hour unless someone is waiting to use the ring. If no one is waiting, members may extend a training session beyond one hour.
7. Members (and guests) should be courteous and communicate with each other while training to ensure shared access to the training area and equipment with other members and guests.
8. Happy Dogs Training Center does not proscribe a particular training philosophy. Members and guests are responsible for training their own dogs using the methods and techniques of their choosing.
